


monart will reserve a percentage of the initial STO and of each transaction to the monart Art Accelerator Initiative (AAI).

monart plans to develop the art world in parallel with a strong social responsibility to promote a global and inclusive art community. The Initiative will be managed in **monart** coins.











THE GROWING GLOBAL ART MARKET

A LONG TIME GROWTH TREND

Big auction houses grew 14.5% annually since 2000! See graph.

Over a 20-year period, post war & contemporary works of art delivered a compound annual return (CAR) of 10.7 % above the Standard & Poor total return of 8.3%. Source Deloitte Art & Finance report.

Sales in the global art market reached \$63.7 billion in 2017, up 12% from 2016.

Post War and Contemporary art was the largest sector by value in 2017, accounting for 46%, followed by Modern art (27%), Source The Art Market 2018, Art Basel & UBS Report 2018

A CONTINUING TREND, OFFLINE AND ONLINE

73% of wealth managers expect their client to include art and collectibles as part of their overall wealth reporting (up from 58% in 2014 and 40% in 2012). Source Deloitte Art & Finance report.

PROVEN AND SECURE TECHNOLOGY

STO PLATFORM

monart STO will run on a highly secure platform including important features such as AML and KYC.

TOKEN INVESTMENT LIQUIDITY

monart will work with a growing number of exchanges and with a market maker to ensure the liquidity of the monart tokens (MART) between monart tokens and Ethereum, Bitcoins, Fiats, etc.

WEBSITE

The current monart website is hosted by one of the largest hosting company, OVH, offering a solid and secure infrastructure including DDOS protection and more. monart's team is currently working to develop the platform MVP to showcase the future site.

The database for subscription and emailing is hosted by one the standard emailing tool, mailchimp. Data is secure, private and never sold or rented.

COMMUNITY ART PLATFORM

The platform will provide a vast and secure environment including redundant servers, advanced database solutions, encrypted data.

WALLETS

For their tokens, monart's users will be provided with simple to use and highly secure wallets, accessible both on smart phones/tablets and Mac/PCs.





MONART ARTWORKS SECURING METHOD

monart builds a highly secure artwork protection, verification, traceable system based on a rigorous proprietary security protocol.

ARTIST VERIFICATION

Based on proprietary enhanced KYC methods, monart certifies the artist identity and work.

ARTWORK VERIFICATION AND CERTIFICATION

The artwork is certified using proprietary technology and high definition pictures taken by our large network of certified professional photographers worldwide, encrypted in the blockchain to be tamper proof. **monart** proprietary technology allows for later verification and certification of the artwork in the database.

The physical artworks will be secured by combined methods: a digital footprint by our worldwide network of certified professional photographers registered with a military grade digital hash in the blockchain transaction, an RFID - NFC tag and an ID tags integrated in the work depending on its nature. For digital artworks, the secure footprint is produced and registered in the blockchain transaction, enclosed in a secured shell that may be executable or not, depending on ownership.

CERTIFIED PROCESS

The entire secure process will be certified by a recognized international certification companies such as UL (www.UL.com).



MONART CERTIFICATION SYSTEM IS MORE SECURE THAN TRADITIONAL PROPOSED SOLUTIONS

Some current proposed blockchain based security systems are solely based on individual's validating the artwork. There is little security in such a system that can be easily forged. Others issue a unique ID to an artist and secure it on the blockchain, ultimately with decreased trust that the artwork is truly genuine.








MONART TOKENS YOU CAN TRUST



Vast and real ecosystem

MonArt creates a real ecosystem to vastly increase the current 63 billion \$/year art market worldwide.

Art investment

monart creates an art financial institution you can trust. 50% of the token STO proceeds are invested in an art collection whose 100% of gross profits are paid to token holders in addition with 10% on gross profits of all transactions on the marketplace as a strong value base for the monart token stability and valuation.

AML & KYC Compliance

As for financial institutions, monart dedicates important resources to AML (Anti Money Laundering) and KYC (Know Your Customer).

Secrecy

All transactions are safely recorded for optimal security and secrecy.





TOKEN ECONOMICS

There are 3 types of Security Tokens: based on assets, based on revenues or based on debts. monart Token (MART) is a Security Token based on revenues with 2 large sources of revenues as described bellow.

Revenues for token holders

Revenues combine:

- 100% of gross profits from the large monart art collection (purchased with half of the STO proceeds).
- 10% of the marketplace transactions gross profits is also paid to token holders

In addition, token holders benefit from many privileges including private sales, discount sales, exclusive art collection creation, VIP events invitations and many other perks, see bellow.

Revenues payments to token holders

Revenues are available for payment any time the token holders wishes to request for them provided there is a minimum amount of revenues to be shared. Monart publishes on a regular base this minimum to redistribute.

Revenues are paid in **monart** tokens, directly to the token holder wallet.

As for the Business Plan, all detailed revenue forecasts are available on request.

monart token economics examples

Revenues paid to token holders from the art collection

Example: an artwork purchased 5.000 euros and sold 10.000 euros after tax, VAT and platform fees.

Gross profit is 5.000 euros. This whole amount is paid back to token holders

Revenues paid to token holders from the transactions on the marketplace

Example: an artwork is sold on the marketplace for 10.000 euros after tax & VAT. The marketplace commission is usually 35% for artists that monart represents, promotes and sells.

Gross profit is 3.500 euros. 10% of this, ie 350 euros, is paid back to token holders.



PROVEN AND SECURE TOKEN TECHNOLOGY

monart Token (MART) is based initially on the current and most used blockchain standard Ethereum ERC20. monart Security Token relies on the Ethereum protocol to provide the safest environment and ecosystem for all art related transactions and activities. monart will later create its own Blockchain to better serve the art community with even faster solutions.

monart uses 2 token types:

- Security tokens based on standard ERC20 tokens sold through the STO as revenue based security tokens providing large revenues from the collection profits and from the platform transactions. They can also be used by everyone to purchase artwork, help promote artists, buy event entries, pay in art shops, etc.
- Standard ERC721 unique security tokens are used to represent each artwork proposed or presented on the monart platform. One ERC721 monart token can represent one or more artworks. Each ERC721 monart token can be the property of one person or of a group of persons sharing the same artwork or group of artworks.

The difference between those two types of tokens is what is called fungible and non-fungible tokens. Fungible tokens are all representing the same thing like bank notes; a 10 euro bank note is equivalent to another one. ERC20 are fungible tokens. A non-fungible token is a different type of token which represents something unique; non-fungible tokens are thus not directly interchangeable. ERC721 tokens are non-fungible tokens.

For share of artworks or of groups of artworks, monart's experienced development team is coding a special proprietary implementation and addition to the ERC721 standard. The monart development team is also analyzing new emerging ERC standards as the ERC998 and ERC1155 which may be used later, depending on services rendered and stability.





PROVEN AND SECURE TOKEN TECHNOLOGY

BLOCKCHAIN

A blockchain is a public ledger of all transactions in a given system that have ever been executed. It is constantly growing as completed blocks are added to it. The blocks are added to the blockchain in linear, chronological order through cryptography, ensuring they remain beyond the power of manipulators.

Building on the foundation created by Bitcoin, initiated in 2008, Ethereum, introduced in 2014 and launched in 2015, is the largest and most well-established, open-ended decentralized software platform that enables Smart Contracts and Distributed Applications (ĐApps) to be built and run without any downtime, fraud, control or interference from a third party. Ethereum is not simply a platform but also a programming language for smart contracts.

SMART CONTRACTS

Smart contracts are automatic and digital executions of a binding agreement between two or more parties. Ethereum is a much more sophisticated environment than Bitcoin but is based on the same secure foundation of the blockchain. Ethereum is also significantly faster than Bitcoin as an Ethereum transaction is confirmed in seconds compared to minutes for Bitcoin.




